HB 1517 Frank Relating to licensing and oversight of certain facilities and homes providing substitute care for children in the conservatorship of the Department of Family and Protective Services.

HB 1990 Wu Relating to requiring the Department of Family and Protective Services to notify certain individuals of changes to child abuse and neglect investigation reports.

HB 2229 Goodwin | et al. Relating to the notice given to certain victims of family violence. HB 2243 Campos Relating to the provision of assistance to elderly persons in obtaining certain protective orders.

HB 2307 Hull Relating to the retention by a managed care organization of certain money recovered as a result of a fraud or abuse investigation under Medicaid or the child health plan program.

HB 2359 Walle Relating to employee caseload limit goals for child and adult protective services and child-care licensing services and call processing goals for certain of those services.

HB 2572 Lujan Relating to the central registry of names of individuals found to have abused or neglected a child.

HB 2641 Johnson, Ann Relating to Medicaid coverage and reimbursement for the provision of rapid whole genome sequencing to certain infants with acute or complex illnesses.
