SECTION 3. Chapter 501, Government Code, is amended by 1 2 adding Subchapter F to read as follows: 3 SUBCHAPTER F. ELIMINATION OF SEXUAL ASSAULT AGAINST INMATES Sec. 501.171. DEFINITIONS. In this subchapter: 4 (1) "Correctional facility" means a facility operated 5 6 by or under contract with the department. 7 (2) "Inmate" means an inmate or state jail defendant confined in a facility operated by or under contract with the 8 department. 9 10 Sec. 501.172. APPOINTMENT OF OMBUDSPERSON. The board shall appoint an ombudsperson to coordinate the department's efforts to 11 12 eliminate the occurrence of sexual assault in correctional facilities. The ombudsperson shall report to the board. 13 14 Sec. 501.173. POWERS AND DUTIES OF OMBUDSPERSON. (a) The 15 ombudsperson shall: 16 (1) monitor department policies for the prevention of 17 sexual assault in correctional facilities; (2) oversee the <u>administrative</u> investigation 18 of 19 inmate complaints of sexual assault; 20 (3) ensure the impartial resolution of inmate 21 complaints of sexual assault; and 22 (4) collect statistics regarding all allegations of sexual assault from each correctional facility in accordance with 23 24 the standards established by the National Prison Rape Elimination 25 Commission. (b) The ombudsperson may collect evidence at correctional 26 facilities and interview inmates or employees at correctional 27

3	(c) The ombudsperson may not require an inmate who reports a
4	sexual assault to assist in the investigation or prosecution of the

6	Sec. 501.174. DEPARTMENT TO ADOPT POLICY. The department
7	shall adopt a policy providing for:
8	(1) a designated administrator at each correctional
9	facility to post information throughout the facility describing how
10	an inmate may confidentially contact the ombudsperson regarding a

12	(2) an inmate to write a confidential letter to the
13	ombudsperson regarding a sexual assault;

8	(c) The annual report must meet the financial reporting
9	requirements of the General Appropriations Act.
10	(d) Upon review of the findings of the annual report
11	submitted to the board, the board shall make recommendations on, or
12	implement policy that has the goal of, lowering the rate and
13	incidence of sexual assault against inmates at a correctional
14	facility. That policy will include methods to address a
15	correctional facility where the rate and incidence of sexual
16	assault against inmates has not shown improvement.

18	ACCESS TO INFORMATION NOT IMPAIRED. This subchapter or other law
19	related to the operation of the ombudsperson or the office of the
20	inspector general does not prohibit the state auditor from
21	conducting an audit, investigation, or other review or from having
22	full and complete access to all records and other information,
23	including witnesses and electronic data, that the state auditor
24	considers necessary for the audit, investigation, or other review.
25	Sec. 501.178. AUTHORITY OF STATE AUDITOR TO CONDUCT TIMELY
26	AUDITS NOT IMPAIRED. This subchapter or other law related to the
27	operation of the ombudsperson or the office of the inspector

H.B. No. 1944 1 general does not take precedence over the authority of the state 2 auditor to conduct an audit under Chapter 321 or other law.

Subsection (c-1), Article SECTION 4. 57.03, Code 3 of 4 Criminal Procedure, as added by this Act, applies only to an offense committed on or after the effective date of this Act. An offense 5 6 committed before the effective date of this Act is governed by the 7 law in effect when the offense was committed, and the former law is 8 continued in effect for that purpose. For purposes of this section, 9 an offense was committed before the effective date of this Act if any element of the offense was committed before that date. 10

SECTION 5. Not later than December 1, 2008, the Texas Department of Criminal Justice shall appoint an ombudsperson and adopt a policy as required by Subchapter F, Chapter 501, Government Code, as added by this Act.

15 SECTION 6. Not later than January 1, 2009, the ombudsperson 16 of the Texas Department of Criminal Justice shall submit the first 17 report required by Section 501.176, Government Code, as added by 18 this Act.

19 SECTION 7. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2007.
