that interferes with the readability of the letters or numbers of 1 2 [on] the <u>license</u> plate <u>number</u> or the name of the state in which the 3 vehicle is registered; or 4 (7) has a coating, covering, [or] protective material, or other apparatus that: 5 distorts 6 (A) angular visibility or 7 detectability; [or] alters or obscures one-half or more of the (B) 8 9 name of the state in which the vehicle is registered; or (C) alters or obscures the letters or numbers of 10 [on] the <u>license</u> plate <u>number or</u> $[\tau]$ the color of the plate $[\tau - or$ 11 another original design feature of the plate]. 12 13 (c) Subsection (a)(7) may not be construed to apply to: (1) a trailer hitch installed on a vehicle in a normal 14 15 or customary manner; 16 (2) a transponder, as defined by Section 228.057, that is attached to a vehicle in the manner required by the issuing 17 authority; 18 (3) a wheelchair lift or wheelchair carrier that is 19 attached to a vehicle in a normal or customary manner; 20 (4) a trailer being towed by a vehicle; or 21 22 (5) a bicycle rack that is attached to a vehicle in a 23 normal or customary manner. SECTION 2. The change in law made by this Act applies (a) 24 25 only to an offense committed on or after the effective date of this Act. For purposes of this section, an offense is committed before 26 the effective date of this Act if any element of the offense occurs 27

2 (b) An offense committed before the effective date of this 3 Act is covered by the law in effect when the offense was committed, 4 and the former law is continued in effect for that purpose.

SECTION 3. This Act takes effect September 1, 2007.
