8	CHAPTER 8236. WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 2
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8236.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the Waller County Municipal
14	Utility District No. 2.
15	Sec. 8236.002. NATURE OF DISTRICT. (a) The district is a
16	municipal utility district created under and essential to
17	accomplish the purposes of Section 59, Article XVI, Texas
18	Constitution.
19	(b) The district, to the extent authorized by Section
20	8236.103 and Section 52, Article III, Texas Constitution, has road
21	powers.
22	Sec. 8236.003. CONFIRMATION ELECTION REQUIRED. The board
23	shall hold an election to confirm the creation of the district as
24	provided by Section 49.102, Water Code.

1	Sec. 8236.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. All
2	land and other property in the district will benefit from the
3	improvements and services to be provided by the district.
4	Sec. 8236.005. INITIAL DISTRICT TERRITORY. (a) The
5	district is initially composed of the territory described by
6	Section 2 of the Act creating this chapter.
7	(b) The boundaries and field notes contained in Section 2 of
8	the Act creating this chapter form a closure. A mistake in the
9	field notes or in copying the field notes in the legislative process
10	does not affect the district's:
11	(1) organization, existence, or validity;
12	(2) right to issue any type of bond for a purpose for
13	which the district is created or to pay the principal of and
14	interest on the bond;
15	(3) right to impose an assessment or tax; or
16	(4) legality or operation.
17	Sec. 8236.006. EFFECT OF CHAPTER ON BROOKSHIRE-KATY
18	DRAINAGE DISTRICT OF WALLER COUNTY. This chapter does not affect
19	the powers of the Brookshire-Katy Drainage District of Waller
20	County.

23	Sec. 8236.051. GOVERNING BODY; TERMS. (a) The district is
24	governed by a board of five elected directors.
25	(b) Directors serve staggered four-year terms.
26	Sec. 8236.052. INITIAL DIRECTORS. (a) The initial board
27	consists of:

1	(1) Jason Kelly;
2	(2) Sandra E. Baggett;
3	(3) Irma Ocampo;
4	(4) Paul Cornett; and
5	(5) Ben Stamets.
6	(b) Unless the initial board agrees otherwise, the initial
7	directors shall draw lots to determine which two shall serve until
8	the first regularly scheduled election of directors and which three
9	shall serve until the second regularly scheduled election of
10	directors.
11	(c) This section expires September 1, 2014.

13	SUBCHAPTER C. POWERS AND DUTIES
14	Sec. 8236.101. GENERAL POWERS AND DUTIES. The district has
15	the powers and duties necessary to accomplish the purposes for
16	which the district is created.
17	Sec. 8236.102. MUNICIPAL UTILITY DISTRICT POWERS AND
18	DUTIES. The district has the powers and duties provided by the
19	general law of this state, including Chapters 49 and 54, Water Code,
20	applicable to municipal utility districts created under Section 59,
21	Article XVI, Texas Constitution.
22	Sec. 8236.103. ROAD PROJECTS. (a) Under Section 52,
23	Article III, Texas Constitution, the district may finance,
24	construct, or acquire a road project as provided by this section.
25	(b) The district shall employ or contract with a licensed
26	engineer to certify whether a proposed road project meets the
27	criteria for a thoroughfare, arterial, or collector road of:

1	(1) a county in whose jurisdiction the proposed road
2	project is located; or
3	(2) a municipality in whose corporate limits or
4	extraterritorial jurisdiction the proposed road project is
5	located.
6	(c) The district may finance, construct, or acquire a road
7	that has been certified by the licensed engineer as a thoroughfare,
8	arterial, or collector road, or any improvements in aid of the
9	certified road.
10	(d) A road project must meet all applicable standards,
11	regulations, ordinances, or orders of:
12	(1) each municipality in whose corporate limits or
13	extraterritorial jurisdiction the road project is located; and
14	(2) if the road project is not located in the corporate
15	limits of a municipality, each county in which the road project is
16	located.
17	(e) The district may, with the consent of the municipality
18	or county, convey a completed road project to:
19	(1) a municipality in whose corporate limits or
20	extraterritorial jurisdiction the road project is located; or
21	(2) a county in which the road project is located.
22	Sec. 8236.104. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
23	OR RESOLUTION. The district shall comply with all applicable
24	requirements of any ordinance or resolution, adopted by the
25	governing body of a municipality under Section 54.016, Water Code,
26	that consents to the creation of the district or to the inclusion of
27	land in the district.

2	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
3	Sec. 8236.151. ELECTIONS REGARDING TAXES OR BONDS.
4	(a) The district may issue, without an election, bonds and other
5	obligations secured by revenue or contract payments from a source
6	other than ad valorem taxation.
7	(b) The district must hold an election in the manner
8	provided by Chapters 49 and 54, Water Code, to obtain voter approval
9	before the district may impose an ad valorem tax or issue bonds
10	payable from ad valorem taxes.
11	(c) The district may not issue bonds payable from ad valorem
12	taxes to finance a road project unless the issuance is approved by a
13	vote of a two-thirds majority of district voters voting at an
14	election held for that purpose.
15	Sec. 8236.152. OPERATION AND MAINTENANCE TAX. (a) If
16	authorized at an election held under Section 8236.151, the district
17	may impose an operation and maintenance tax on taxable property in
18	the district as provided by Section 49.107, Water Code.
19	(b) The board shall determine the tax rate. The rate may not
20	exceed the rate approved at the election.

22	SUBCHAPTER E. BONDS
23	Sec. 8236.201. AUTHORITY TO ISSUE BONDS AND OTHER
24	OBLIGATIONS. The district may issue bonds or other obligations
25	payable wholly or partly from ad valorem taxes, impact fees,
26	revenue, grants, or other district money, or any combination of
27	those sources, to pay for any authorized district purpose.

Sec. 8236.202. BONDS FOR ROAD PROJECTS. At the time of 1 2 issuance, the total principal amount of a bond, note, or other obligation issued or incurred to finance a road project may not 3 exceed one-fourth of the assessed value of real property in the 4 district according to the most recent certified tax appraisal roll 5 for Waller County. 6 7 Sec. 8236.203. TAXES FOR BONDS AND OTHER OBLIGATIONS. At the time bonds or other obligations payable wholly or partly from ad 8 9 valorem taxes are issued: 10 (1) the board shall impose a continuing direct annual ad valorem tax, without limit as to rate or amount, for each year 11 that all or part of the bonds are outstanding; and 12 13 (2) the district annually shall impose an ad valorem tax on all taxable property in the district in an amount sufficient 14 15 to: 16 (A) pay the interest on the bonds or other obligations as the interest becomes due; 17 18 (B) create a sinking fund for the payment of the principal of the bonds or other obligations when due or the 19 redemption price at any earlier required redemption date; and 20 (C) pay the expenses of imposing the taxes. 21 22 SECTION 2. The Waller County Municipal Utility District No. 2 initially includes all the territory contained in the following 23 24 area: 25 Being a 419.987-acre (18,294,644 square foot) tract of land situated in the H. &T.C.R.R. Survey, Section 73, A-154, the T.S. 26 Reese Survey, A-330 and the Nathan Brookshire Survey, A-16, Waller 27

County, Texas, being out of a 150.62-acre tract of land recorded in 1 2 Volume 262, Page 403 of the Waller County Deed Records, being out of 3 a 93.675-acre tract of land recorded in Volume 240, Page 93 of the 4 Waller County Deed Records, being out of a 24.1408-acre tract of land recorded in Volume 250, Page 9 of the Waller County Deed 5 Records, being out of a 302.299-acre tract of land recorded in 6 7 Volume 233, Page 774 of the Waller County Deed Records, being out of a 191.19-acre tract of land recorded in Volume 237, Page 329 of the 8 9 Waller County Deed Records and being more particularly described by 10 metes and bounds as follows:

THENCE South 86° 30' 38" West, a distance of 1,396.67 feet with the northerly line of said 30-acre tract and with the northerly line of the Howard L. Brookshire 30-acre tract of land as recorded in Volume 147, Page 248 of the Waller County Deed Records to a 1-1/2-inch iron pipe found for an interior corner of this tract;

27 THENCE South 03° 34' 47" East, a distance of 703.09 feet with the

westerly line of said Howard L. Brookshire 30-acre tract to a 1-1/2-inch iron pipe found for an angle point of this tract;

3 THENCE South 02° 27' 11" East, a distance of 364.21 feet with the 4 westerly line of said Howard L. Brookshire 30-acre tract to a 5 5/8-inch iron rod with cap stamped "Weisser Eng. Houston, Tx." set 6 for a southeasterly corner of this tract;

Houston, Tx." set for a point-of-tangency, 11 from which a 4-inch concrete monument found bears South 79° 35' 01" 12 13 East, a distance of 0.73 feet;

14 THENCE South 51° 42' 45" East, a distance of 463.64 feet with the 15 southerly right-of-way line of said Interstate Highway No. 10 to a 16 5/8-inch iron rod with cap stamped "Weisser Eng. Houston, Tx." set 17 for a point-of-curvature, from which a 4-inch concrete monument 18 found bears South 77° 49' 56" East, a distance of 1.16 feet;

THENCE In an easterly direction with the southerly right-of-way 19 20 line of said Interstate Highway No. 10 and with a tangent curve to the left having a radius of 612.96 feet, central angle of 40° 00' 21 00", a length of 427.93 feet and a chord bearing South 71° 42' 45" 22 East, a distance of 419.29 feet to a 5/8-inch iron rod with cap 23 stamped "Weisser Eng. Houston, Tx." set for a point-of-tangency, 24 25 from which a 4-inch concrete monument found bears South 66° 01' 45" East, a distance of 0.52 feet; 26

27 THENCE North 88° 17' 15" East, a distance of 105.30 feet with the

southerly right-of-way line of said Interstate Highway No. 10 to the POINT OF BEGINNING and containing 419.987 acres (18,294,644 square feet) of land.

4 SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this 5 Act, has been published as provided by law, and the notice and a 6 7 copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished 8 9 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 10 Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.

The Texas Commission on Environmental Quality has filed 14 (C) 15 its recommendations relating to this Act with the governor, the 16 lieutenant governor, and the speaker of the house of representatives within the required time. 17

(d) All requirements of the constitution and laws of this
state and the rules and procedures of the legislature with respect
to the notice, introduction, and passage of this Act are fulfilled
and accomplished.

22 SECTION 4. This Act takes effect immediately if it receives 23 a vote of two-thirds of all the members elected to each house, as 24 provided by Section 39, Article III, Texas Constitution. If this 25 Act does not receive the vote necessary for immediate effect, this 26 Act takes effect September 1, 2007.
