5	ARTICLE 1. CHILDREN'S BILL OF RIGHTS
6	SECTION 1.01. Chapter 151, Family Code, is amended by
7	adding Section 151.005 to read as follows:
8	Sec. 151.005. CHILDREN'S BILL OF RIGHTS. (a) It is the
9	intent of the legislature to ensure that:
10	(1) children are the number one priority of this
11	state; and
12	(2) parents are educated regarding their duties under
13	law as the primary protectors of their children.
14	(b) It is the policy of this state that each child has the
15	right to:
16	(1) live in a safe, healthy, and comfortable home in
17	which the child is treated with respect;
18	(2) be free from physical, sexual, emotional, and
19	other abuse or neglect and any form of discipline that humiliates or
20	demeans the child;
21	(3) receive adequate and healthy food;
22	(4) receive access to a quality education; and
23	(5) receive appropriate medical, dental, vision, and
24	mental health services.

3	Sec. 265.006. PUBLIC AWARENESS AND OUTREACH CAMPAIGN
4	REGARDING CHILDREN'S BILL OF RIGHTS. (a) Not later than September
5	1, 2010, the department shall develop and implement a statewide
6	public awareness and outreach campaign designed to educate the
7	public regarding the legislature's adoption and content of the
8	children's bill of rights under Section 151.005.
9	(b) The department may solicit and accept gifts, grants, and
10	donations from any public or private source for purposes of this
11	section.
12	(c) This section expires December 31, 2011.
13	SECTION 1.03. Subchapter A, Chapter 192, Health and Safety
14	Code, is amended by adding Section 192.0035 to read as follows:
15	Sec. 192.0035. PRESENTATION TO PARENTS OF PROCLAMATION OF
16	CHILDREN'S BILL OF RIGHTS. (a) As soon as practicable after a
17	child's birth or adoption certificate is filed under this chapter
18	or a child's birth is reported under this chapter, the department
19	shall present to each of the child's parents a written proclamation
20	of the children's bill of rights prescribed by Section 151.005,
21	Family Code.
22	(b) The department, in consultation with the office of the
23	governor, shall establish the form, content, and manner of
24	presentation of the proclamation required by this section. The
25	proclamation must include a signed statement from the governor
26	congratulating the parent on the child's birth and informing the
27	parent of the parent's duties in relation to the child imposed under

2	(c) The executive commissioner of the Health and Human
3	Services Commission shall adopt rules for the administration of

5	ARTICLE 2. FAMILY EDUCATION CENTERS
6	SECTION 2.01. Subchapter F, Chapter 130, Education Code, is
7	amended by adding Section 130.093 to read as follows:
8	Sec. 130.093. FAMILY EDUCATION CENTERS. (a) The board of
9	trustees of a junior college district may establish, in conjunction
10	with other public or private institutions of higher education and
11	other participating private entities, a family education center.
12	The family education center must be administered under a formal
13	agreement entered into by the district with the other member
14	institutions and entities.
15	(b) The family education center shall provide comprehensive
16	family educational activities and training to the residents of the
17	region in which the center is located.
18	(c) The member institutions and entities of the family
19	education center shall establish the curriculum for the center in
20	consultation with the prevention and early intervention services
21	division of the Department of Family and Protective Services. The
22	curriculum must be designed to:
23	(1) educate parents regarding their duties under law
24	as the primary protectors of their children;
25	(2) promote the prevention and amelioration of child
26	abuse and neglect;
27	(3) reduce the need for state and local services

1 addressing child maltreatment; and 2 (4) engage family members in individual and group 3 sessions designed to: 4 (A) prevent the occurrence of family violence; 5 (B) address addiction problems and other mental 6 health issues of family members; 7 (C) equip family members with strategies to 8 reduce stress and anxiety and creative ideas for family activities; (D) foster communication, respect, forgiveness, 9 10 and intimacy among family members; 11 (E) build self-esteem; 12 (F) develop short- and long-term family goals; (G) develop vocational skills; 13 (H) develop life skills, including skills 14 15 relating to parenting, discipline, positive reinforcement, infant care, household budgeting, financial planning, daily planning of 16 17 household chores, nutrition and wellness, personal care, and community volunteerism; and 18 (I) address any other family educational goals of 19 the local community served by the center. 20 21 (d) The member institutions and entities of the family education center shall work with the local community to identify 22 and offer courses that will meet the family educational goals for 23 24 the region served by the center. 25 (e) The member institutions and entities of the family 26 education center, under the terms of the formal agreement, may make 27 provisions for adequate physical facilities for use by the center.

5	SECTION 2.02. Chapter 265, Family Code, is amended by adding
6	Sections 265.007 and 265.008 to read as follows:
7	Sec. 265.007. FAMILY EDUCATION CENTER CURRICULUM
8	DEVELOPMENT. On request by the member institutions and entities of
9	a family education center established under Section 130.093,
10	Education Code, the department shall assist the member institutions
11	and entities in developing a comprehensive curriculum for the
12	center designed to meet the goals prescribed by Section 130.093(c),
13	Education Code.
14	Sec. 265.008. FEASIBILITY STUDY REGARDING FAMILY EDUCATION
15	CENTERS; REPORT. (a) The department shall evaluate the feasibility
16	of requiring certain families who are the subject of a report of
17	alleged abuse or neglect of a child under this subtitle to
18	participate in educational activities offered by a family education
19	center established under Section 130.093, Education Code, as an
20	alternative to removing the child from the child's home.
21	(b) Not later than December 1, 2010, the department shall
22	prepare and submit to the lieutenant governor, the speaker of the
23	house of representatives, and the members of the legislature a
24	report containing the department's findings regarding the
25	feasibility study conducted by the department under Subsection (a)
26	and the department's recommendations regarding whether family
27	education centers should be established statewide.

1	(c) This section expires September 1, 2011.
2	ARTICLE 3. EFFECTIVE DATE
3	SECTION 3.01. This Act takes effect immediately if it
4	receives a vote of two-thirds of all the members elected to each
5	house, as provided by Section 39, Article III, Texas Constitution.
6	If this Act does not receive the vote necessary for immediate
7	effect, this Act takes effect September 1, 2009.
