5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter D, Chapter 502, Transportation Code,
7	is amended by adding Sections 502.1747 and 502.1748 to read as
8	follows:
9	Sec. 502.1747. VOLUNTARY CONTRIBUTION TO PARKS AND WILDLIFE
10	DEPARTMENT. (a) When a person registers or renews the registration
11	of a motor vehicle under this chapter, the person may contribute \$5
12	or more to the Parks and Wildlife Department.
13	(b) The department shall:
14	(1) include space on each motor vehicle registration
15	renewal notice, on the page that states the total fee for
16	registration renewal, that allows a person renewing a registration
17	to indicate the amount that the person is voluntarily contributing
18	to the state parks account;
19	(2) provide an opportunity to contribute to the state
20	parks account similar to the opportunity described by Subsection
21	(a) and in the manner described by Subdivision (1) in any
22	registration renewal system that succeeds the system in place on
23	September 1, 2011; and
24	(3) provide an opportunity for a person to contribute

1 to the state parks account during the registration renewal process 2 on the department's Internet website. 3 (c) If a person makes a contribution under this section and does not pay the full amount of a registration fee, the county 4 5 assessor-collector may credit all or a portion of the contribution 6 to the person's registration fee. 7 (d) The county assessor-collector shall send any contribution made under this section to the comptroller for deposit 8 to the credit of the state parks account under Section 11.035, Parks 9 10 and Wildlife Code. Money received by the Parks and Wildlife Department under this section may be used only for the operation and 11 12 maintenance of state parks, historic sites, or natural areas under the jurisdiction of the Parks and Wildlife Department. 13 14 (e) The department shall consult with the Parks and Wildlife 15 Department in performing the department's duties under this 16 section. 17 Sec. 502.1748. DISPOSITION OF CERTAIN VOLUNTARY CONTRIBUTIONS. If a person makes a voluntary contribution under 18 19 Section 502.1746 or 502.1747 at the time the person registers or renews the registration of a motor vehicle under this chapter but 20 the person does not clearly specify the entity to which the person 21 22 intends to contribute, the county assessor-collector shall divide the contribution between the entities authorized to receive 23 24 contributions under those sections. SECTION 2. Sections 502.1747 and 502.1748, Transportation 25

26 Code, as added by this Act, apply only to a motor vehicle 27 registration renewal notice issued for a registration that expires

1 on or after January 1, 2012.

2 SECTION 3. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2011.
