4 SECTION 1. Section 466.003(a), Government Code, is amended  
5 to read as follows:

6 (a) The lottery division is [~~subject to Chapter 325 (Texas~~  
7 ~~Sunset Act). Unless continued in existence as provided by that~~  
8 ~~chapter, the division is~~] abolished and this chapter expires August  
9 31, 2017 [~~September 1, 2005~~]. [~~In the review of the lottery~~  
10 ~~division by the Sunset Advisory Commission, as required by this~~  
11 ~~section, the sunset commission shall limit its review to the~~  
12 ~~appropriateness of recommendations made by the sunset commission to~~  
13 ~~the 78th Legislature. In the Sunset Advisory Commission's report~~  
14 ~~to the 79th Legislature, the sunset commission may include any~~  
15 ~~recommendations it considers appropriate.~~]

16 SECTION 2. Section 467.002, Government Code, is amended to  
17 read as follows:

18 Sec. 467.002. APPLICATION OF SUNSET ACT. The commission is  
19 subject to Chapter 325 (Texas Sunset Act). Unless continued in  
20 existence as provided by that chapter, the commission is abolished  
21 and this chapter[, ~~Chapter 466 of this code,~~] and Chapter 2001,  
22 Occupations Code, expire September 1, 2023 [~~2013~~].

23 SECTION 3. Effective August 31, ~~2015~~, Sections 467.101(a)  
24 and (c), Government Code, are amended to read as follows:

25 (a) The commission has broad authority and shall exercise  
26 strict control and close supervision over all activities authorized  
27 and conducted in this state under[+]

28 [(1)] Chapter 2001, Occupations Code[+, and

29 [(2)] ~~Chapter 466 of this code~~].

(c) The commission also has the powers and duties granted

1 under[+

2           ~~[(1)]~~ Chapter 2001, Occupations Code. Notwithstanding  
3 any other law, the commission's powers and duties related to the  
4 state lottery, other than payment of any outstanding prizes awarded  
5 for the sale of a lottery ticket before September 1, <sup>2017</sup>~~2015~~, expire on  
6 that date~~[, and~~

7           ~~[(2)] Chapter 466 of this code~~].

8           SECTION 4. Except as otherwise provided by this Act, this  
9 Act takes effect September 1, 2013.
