- 1 Amend H.R. No. 4 (adopting the rules of the house) as
- 2 follows:
- 3 (1) On page 177, line 13, strike "one" and substitute "12
- 4 [one]".
- 5 (2) On page 177, line 19, after the period, strike the
- 6 last sentence.
- 7 (3) On page 177, between lines 21 and 22, insert the
- 8 following:
- 9 "(c) No action or recommendation of the house conferees
- 10 that exceeds the limitations imposed on the conference committee
- 11 under Section 9 of this rule is valid unless it is taken at a
- 12 meeting of the house conferees with a quorum of the house
- 13 conferees actually present, and the conferees' minutes shall
- 14 reflect the names of those house conferees who were actually
- 15 present.
- 16 (d) The house may not consider any conference committee
- 17 report adopted in violation of this section."
- 18 (4) On page 177, line 22, between "(a)" and "House",
- 19 insert "Except as provided by Subsection (a-1),"
- On page 178, between lines 1 and 2, insert the following:
- 21 "(a-1) No action or recommendation of the house conferees
- 22 that exceeds the limitations imposed on the conference committee
- 23 under Section 9 of this rule is valid unless the house conferees
- 24 meet in a public meeting that is noticed and held in the same
- 25 manner as a public meeting of a standing committee under Rule 4,
- 26 Sections 9-12. Minutes of each meeting held under this section
- 27 must be kept and filed as provided by Rule 4, Section 18, and
- 28 must include, for action on a specific matter that would be
- 29 prohibited by the limitations imposed by Section 9 of this rule,

- 1 the identity of the member moving that the committee take the
- 2 action and a record of each house conferee's vote on the action.
- 3 The house may not consider any conference committee report
- 4 adopted in violation of this subsection."
- 5 (5) On page 182, line 24, between "house" and the period,
- 6 insert "before the conference committee votes to adopt its final
- 7 report on a bill or joint resolution. The house may not
- 8 consider a conference committee report that exceeds the
- 9 limitations imposed by this section that was adopted by the
- 10 conference committee before permission to exceed those
- 11 limitations is granted."
- 12 (6) On page 185, between lines 18 and 19, insert the
- 13 following:
- "(e) Before the house may consider a conference committee
- 15 report on a bill or joint resolution for which the house
- 16 suspended the limitations of Section 9 of this rule, the minutes
- 17 required under Section 7(a-1) of this rule must be filed and
- 18 available to each member through the electronic legislative
- 19 <u>information system.</u>"
