- 13 <u>(B) originally purchased the exclusive right of</u>

- 15 SECTION 2. Section 711.012(a), Health and Safety Code, is
- 16 amended to read as follows:
- 17 (a) The Finance Commission of Texas may adopt rules to
- 18 enforce and administer $\underline{\text{Subchapter C-1}}$ and $\underline{\text{Sections}}$ 711.003,
- 19 711.004, 711.007, 711.008, 711.0105, 711.021-711.024,
- 20 711.032-711.036, 711.038, <u>711.0381</u>, 711.040-711.042, 711.052, <u>and</u>
- 21 711.061[, and 711.062] relating to perpetual care cemeteries.
- SECTION 3. The heading to Section 711.038, Health and
- 23 Safety Code, is amended to read as follows:
- Sec. 711.038. SALE OF PLOTS BY CEMETERY ORGANIZATIONS.

- 1 SECTION 4. Section 711.038(e), Health and Safety Code, is
- 2 amended to read as follows:
- 3 (e) A person who is an officer, agent, or employee of the
- 4 cemetery organization or its affiliate and who is exempt from
- 5 registration under Subchapter C-1 is not required to be licensed or
- 6 registered to sell a plot in a dedicated cemetery.
- 7 SECTION 5. Subchapter C, Chapter 711, Health and Safety
- 8 Code, is amended by adding Section 711.0381 to read as follows:
- 9 Sec. 711.0381. SALE OR RESALE OF PLOTS BY CERTAIN PERSONS.
- 10 (a) A person may not act as a cemetery broker in the sale or resale
- 11 of the exclusive right of sepulture in a plot unless the person is
- 12 registered as a cemetery broker under Subchapter C-1 or is exempt
- 13 from registration under Subchapter C-1.
- 14 (b) Resale of the exclusive right of sepulture in a plot is
- 15 subject to the rules of the cemetery organization and any
- 16 restrictions in the certificate of ownership, quitclaim agreement,
- 17 or other instrument of conveyance. A quitclaim agreement or other
- 18 instrument evidencing the conveyance of the exclusive right of
- 19 sepulture must be:
- 20 (1) in a form authorized by or otherwise acceptable to
- 21 the cemetery organization, subject to Subsection (c);
- 22 (2) signed by:
- (A) the grantee named in the certificate of
- 24 ownership or other instrument of conveyance as filed and recorded
- 25 in the cemetery organization's office in accordance with Section
- 26 <u>711.038 or 711.039(g)(2)</u>, as the seller or transferor;
- 27 <u>(B) the designated purchaser or transferee; and</u>

1	(C) each cemetery broker or other agent assisting
2	in the transfer of the interment rights; and
3	(3) filed and recorded with the cemetery organization
4	not later than the third business day after the date of the sale.
5	(c) On request of a person acting as a cemetery broker, a
6	cemetery organization shall provide its rules, conveyance forms,
7	and written guidelines and procedures for brokered sales, if any.
8	(d) The resale of the exclusive right of sepulture in a
9	group of interment rights that were conveyed collectively may not
10	be divided without the consent of the cemetery organization.
11	(e) A person acting as a cemetery broker that sells or
12	resells the right of sepulture in a plot shall collect and remit to
13	the cemetery organization:
14	(1) all fees required by law; and
15	(2) any other fee required by the rules of the cemetery
16	organization, subject to Subsection (f).
17	(f) A fee required by a rule of the cemetery organization
18	for the sale or resale of the right of sepulture in a plot under this
19	section may not exceed the fee charged by the cemetery organization
20	on the sale of the right of sepulture in a plot under Section
21	<u>711.038.</u>
22	(g) A person acting as a cemetery broker must keep a record
23	of each sale or resale under this section. The record must include:
24	(1) the name and address of the purchaser;
25	(2) the date of the purchase;
26	(3) a copy of the purchase agreement, with the name and
27	address of the cemetery;

1	(4) a specific description of the interment rights;				
2	(5) the purchase price;				
3	(6) the amount of fees collected and remitted in				
4	accordance with Subsection (e); and				
5	(7) information on the disposal of the purchase				
6	agreement, including whether the agreement was conveyed, canceled,				
7	or voided.				
8	SECTION 6. Chapter 711, Health and Safety Code, is amended				
9	by adding Subchapter C-1 to read as follows:				
10	SUBCHAPTER C-1. CEMETERY BROKER REGISTRATION				
11	Sec. 711.045. DEFINITIONS. In this subchapter:				
12	(1) "Commission" means the Finance Commission of				
13	Texas.				
14	(2) "Commissioner" means the banking commissioner of				
15	Texas.				
16	(3) "Department" means the Texas Department of				
17	Banking.				
18	Sec. 711.046. CEMETERY BROKER REGISTRATION. (a) To register				
19	under this subchapter, a cemetery broker shall file with the				
20	department a sworn, notarized statement that contains:				
21	(1) the name and street address of the cemetery				
22	broker;				
23	(2) the name, street address, and telephone number of				
24	the representative of the cemetery broker to be contacted regarding				
25	a written complaint; and				
26	(3) any Internet or other electronic mail address of				
27	the cemetery broker.				

- 1 (b) The registration of a cemetery broker is valid until
- 2 withdrawn or revoked. Periodic renewal of the registration is not
- 3 required.
- 4 (c) A registered cemetery broker shall update the
- 5 information contained in the registration statement not later than
- 6 the 60th day after the date the information changes.
- 7 (d) The department may charge a cemetery broker a reasonable
- 8 fee to cover the costs of filing and maintaining the registration
- 9 statement and administering this chapter. The administration fee
- 10 may not exceed \$100 per year.
- 11 Sec. 711.047. EXEMPTIONS. This subchapter does not apply
- 12 to a person offering to sell or selling the exclusive right of
- 13 sepulture in a plot if the person is:
- 14 (1) an officer, agent, employee, or affiliate of the
- 15 cemetery organization in which the plot is located, acting at the
- 16 <u>direction or under the control of the cemetery organization;</u>
- 17 (2) an employee of a registered cemetery broker;
- 18 (3) with respect to the specific plot for sale:
- 19 (A) a grantee named in the certificate of
- 20 ownership or other instrument of conveyance for the plot as filed
- 21 and recorded in the cemetery organization's office under Section
- 22 711.038;
- 23 (B) a spouse or other heir of the named grantee as
- 24 described by Section 711.039;
- (C) an executor, administrator, or guardian of
- 26 the named grantee appointed by court order; or
- (D) an attorney-in-fact for the named grantee

- 1 under a durable power of attorney if the person is not otherwise
- 2 engaged in the business of a cemetery broker and does not solicit
- 3 appointment as attorney-in-fact for the purpose of offering to sell
- 4 or selling the exclusive right of sepulture of the named grantee; or
- 5 (4) otherwise exempt in accordance with rules adopted
- 6 by the commission as necessary to protect the public health and
- 7 <u>safety.</u>
- 8 Sec. 711.048. COMPLAINTS. (a) A cemetery broker is subject
- 9 to rules adopted under Section 11.307, Finance Code, regarding the
- 10 manner in which the cemetery broker provides consumers with
- 11 <u>information on how to file complaints with the department. The</u>
- 12 rules must be consistent with the obligations imposed by this
- 13 section.
- 14 (b) If the department receives a signed written complaint
- 15 from a person concerning a cemetery broker, the department shall
- 16 provide written notification of the complaint to the cemetery
- 17 broker's designated representative not later than the 31st day
- 18 after the date the complaint was received and provide a copy of the
- 19 complaint to the representative. The department may:
- 20 <u>(1)</u> require the cemetery broker to resolve the
- 21 complaint or to provide the department with a response to the
- 22 complaint; or
- 23 (2) provide written direction requiring the cemetery
- 24 broker to take specific action to resolve the complaint.
- Sec. 711.049. TERMINATION OF REGISTRATION. (a) A cemetery
- 26 broker may withdraw the cemetery broker's registration at any time.
- 27 (b) After notice and opportunity for a hearing, the

- 1 commissioner may revoke the registration of a registered cemetery
- 2 broker that:
- 3 (1) fails to pay the annual administration fee and
- 4 fails to cure the default not later than the 30th day after the date
- 5 written notice of the default is mailed by the department to the
- 6 cemetery broker;
- 7 (2) fails or refuses to comply with the department's
- 8 written request for a response to a complaint; or
- 9 (3) the commissioner concludes, after considering a
- 10 complaint filed under this subchapter, has engaged in an
- 11 intentional course of conduct that:
- 12 (A) violates federal or state law; or
- 13 (B) constitutes improper, fraudulent, or
- 14 dishonest dealings.
- 15 <u>(c)</u> The commissioner shall state the basis of the decision
- 16 in an order revoking the registration of a cemetery broker. The
- 17 cemetery broker may appeal an order revoking registration in the
- 18 manner provided by Chapter 2001, Government Code.
- 19 SECTION 7. Section 711.052(a), Health and Safety Code, is
- 20 amended to read as follows:
- 21 (a) A person who is an individual, firm, association,
- 22 corporation, or municipality, or an officer, agent, or employee of
- 23 an individual, firm, association, corporation, or municipality,
- 24 commits an offense if the person:
- 25 (1) engages in a business for cemetery purposes in
- 26 this state other than through a corporation organized for that
- 27 purpose, if a corporation is required by law;

- 1 (2) fails or refuses to keep records of interment as
- 2 required by Sections 711.003 and 711.004;
- 3 (3) sells, offers to sell, or advertises for sale a
- 4 plot or the exclusive right of sepulture in a plot for purposes of
- 5 speculation or investment; [er]
- 6 (4) represents through advertising or printed
- 7 material that a retail department will be established for the
- 8 resale of the plots of plot purchasers, that specific improvements
- 9 will be made in the cemetery, or that specific merchandise or
- 10 services will be furnished to a plot owner, unless adequate funds or
- 11 reserves are created by the cemetery organization for the
- 12 represented purpose;
- 13 (5) offers or receives monetary inducement to solicit
- 14 business for a cemetery broker;
- 15 (6) fails or refuses to keep records of sales or
- 16 <u>resales or to collect and remit fees as required by Section</u>
- 17 711.0381; or
- 18 (7) fails or refuses to register as a cemetery broker
- 19 as required by Subchapter C-1.
- SECTION 8. Section 711.056(a), Health and Safety Code, is
- 21 amended to read as follows:
- 22 (a) If after a hearing conducted as provided by Chapter
- 23 2001, Government Code, the trier of fact finds that a violation of
- 24 this chapter or a rule of the Finance Commission of Texas
- 25 establishes a pattern of wilful disregard for the requirements of
- 26 this chapter or rules of the finance commission, the trier of fact
- 27 shall recommend to the commissioner that the maximum administrative

- 1 penalty permitted under Section 711.055 be imposed on the person
- 2 committing the violation or that the commissioner cancel or not
- 3 renew:
- 4 (1) the person's registration under Subchapter C-1, if
- 5 the person is registered under that subchapter; or
- 6 (2) the person's permit under Chapter 154, Finance
- 7 Code, if the person holds such a permit.
- 8 SECTION 9. Subchapter D, Chapter 711, Health and Safety
- 9 Code, is amended by adding Sections 711.057, 711.058, and 711.059
- 10 to read as follows:
- Sec. 711.057. EMERGENCY ORDER. (a) The commissioner may
- 12 issue an emergency order that takes effect immediately if the
- 13 commissioner finds that immediate and irreparable harm is
- 14 threatened to the public or a beneficiary under a sale of the
- 15 <u>exclusive right of sepulture in a plot.</u>
- 16 (b) An emergency order remains in effect unless stayed by
- 17 the commissioner.
- 18 (c) The person named in the order may request in writing an
- 19 opportunity for a hearing to show that the emergency order should be
- 20 stayed. On receipt of the request, the commissioner shall set a
- 21 time for the hearing before the 22nd day after the date the
- 22 commissioner received the request, unless extended at the request
- 23 of the person named in the order.
- 24 (d) The hearing is an administrative hearing relating to the
- 25 validity of findings that support immediate effect of the order.
- Sec. 711.058. RESTITUTION. The commissioner may issue an
- 27 order to a person requiring restitution if, after notice and

- 1 opportunity for hearing, the commissioner finds that the person:
- 2 (1) failed to remit a fee in accordance with Section
- 3 711.0381; or
- 4 (2) misappropriated, converted, or illegally withheld
- 5 or failed or refused to pay on demand money entrusted to the person
- 6 that belongs to a cemetery organization under an instrument of
- 7 conveyance.
- 8 Sec. 711.059. SEIZURE OF ACCOUNTS AND RECORDS. (a) The
- 9 commissioner may issue an order to seize accounts in which funds
- 10 from the sale or resale of the exclusive right of sepulture in a
- 11 plot, including earnings, may be held and may issue an order to
- 12 seize the records that relate to the sale or resale of the exclusive
- 13 right of sepulture in a plot if the commissioner finds, by
- 14 examination or other credible evidence, that the person:
- 15 (1) failed to remit a fee in accordance with Section
- 16 711.0381;
- 17 (2) misappropriated, converted, or illegally withheld
- 18 or failed or refused to pay on demand money entrusted to the person
- 19 that belongs to a cemetery organization under an instrument of
- 20 conveyance;
- 21 (3) refused to submit to examination by the
- 22 <u>department;</u>
- 23 (4) was the subject of an order to cancel, suspend, or
- 24 refuse a registration under Subchapter C-1; or
- 25 (5) is required to register under Subchapter C-1 and
- 26 is not registered or has transferred the ownership of the business
- 27 that required registration to another person who is not registered.

- 1 (b) An order shall be served on the person named in the order
- 2 by certified mail, return receipt requested, to the last known
- 3 address of the person.
- 4 (c) An order takes effect immediately and remains in effect
- 5 unless stayed by the commissioner, if the commissioner finds that
- 6 immediate and irreparable harm is threatened to the public or a
- 7 beneficiary under a sale of the exclusive right of sepulture in a
- 8 plot. If such a threat does not exist, the order must state the
- 9 effective date, which may not be before the 16th day after the date
- 10 the order is mailed.
- 11 (d) An emergency order remains in effect unless stayed by
- 12 the commissioner. The person named in the order may request in
- 13 writing an opportunity for a hearing to show that the emergency
- 14 order should be stayed. On receipt of the request, the commissioner
- 15 shall set a time before the 22nd day after the date the commissioner
- 16 received the request, unless extended at the request of the person
- 17 named in the order. The hearing is an administrative hearing
- 18 relating to the findings that support immediate effect of the
- 19 order.
- (e) A nonemergency order takes effect as proposed unless the
- 21 person named in the order requests a hearing not later than the 15th
- 22 <u>day after the date the order is mailed.</u>
- 23 <u>(f) After the issuance of an order under this section, the</u>
- 24 commissioner may initiate an administrative claim for ancillary
- 25 relief, including a claim for:
- 26 (1) costs incurred in the administration, transfer, or
- 27 other disposition of the seized assets and records; or

1	(2) costs reasonably expected to be incurred ir
2	connection with the administration and performance of any
3	outstanding certificate of ownership or other instrument of
4	conveyance that is a part of a sale by the person subject to the
5	order.
6	(g) The remedy provided by Subsection (f) is not exclusive.
7	The commissioner may seek an additional remedy authorized under
8	this subchapter.
9	SECTION 10. Chapter 711, Health and Safety Code, is amended

11	acting as a cemetery broker if the commissioner determines the		
12	examination is necessary to:		
13	(1) safeguard the interests of purchasers and		
14	beneficiaries of the exclusive right of sepulture in a plot; and		
15	(2) efficiently enforce applicable law.		
16	(c) A person may maintain and provide a record required to		
17	be maintained under this section in an electronic format if the		
18	record is reliable and can be retrieved in a timely manner.		
19	Sec. 711.084. EXAMINATION FEE. (a) For each examination		
20	conducted under Section 711.083, the commissioner or the		
21	commissioner's agent shall impose on the cemetery broker a fee in an		
22	amount set by the commission under Section 711.082.		
23	(b) The amount of the fee must be sufficient to cover:		
24	(1) the cost of the examination, including:		
25	(A) salary and travel expenses for department		
26	employees, including travel to and from the place where the records

- 2 conducting the examination;
- 3 (2) the equitable or proportionate cost of maintaining

- 6 SECTION 11. (a) Except as provided by Subsection (b) of
- 7 this section, this Act takes effect immediately if it receives a
- 8 vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. Except as
- 10 provided by Subsection (b) of this section, if this Act does not
- 11 receive the vote necessary for immediate effect, this Act takes
