- 5 SECTION 1. The heading to Section 447.009, Government Code,

- 8 REPORTING.
- 9 SECTION 2. Section 447.009, Government Code, is amended by
- 10 amending Subsection (c) and adding Subsection (e) to read as
- 11 follows:
- 12 (c) The state energy conservation office shall prepare
- 13 guidelines for preparation of the plan described in Subsection
- 14 (a)(3) and develop a template for state agencies and institutions
- of higher education to use in creating the plan. Each state agency
- 16 and institution of higher education shall set percentage goals for
- 17 reducing the agency's or institution's use of water, electricity,
- 18 gasoline, and natural gas and include those goals in the agency's or
- 19 <u>institution's comprehensive energy and water management plan</u>. A
- 20 state agency or an institution of higher education that occupies a
- 21 state-owned building shall prepare and implement a five-year energy
- 22 and water management plan and shall submit that plan to the office
- 23 upon request. The agency or institution shall update its plan
- 24 annually [biennially]. A state agency or an institution of higher

- 1 education that occupies a building not owned by the state shall
- 2 cooperate with the office in addressing the energy or water
- 3 management of that building.
- 4 (e) Not later than December 1 of each even-numbered year,
- 5 the state energy conservation office shall submit a report to the
- 6 governor and the Legislative Budget Board on the status and
- 7 effectiveness of the utility management and conservation efforts of
- 8 state agencies and institutions of higher education. The report
- 9 <u>must include information submitted to the office from each state</u>
- 10 agency and institution of higher education. The office shall post
- 11 the report on the office's Internet website.
- 12 SECTION 3. This Act takes effect September 1, 2013.
