- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 30.06(c)(2), Penal Code, is amended to
- 6 read as follows:
- 7 (2) "License holder" has the meaning assigned by
- 8 Section 46.035(d) [46.035(f)].
- 9 SECTION 2. Section 30.06(e) and (f), Penal Code, is amended
- 10 to read as follows:
- 11 (e) It is an exception to the application of this section
- 12 that the property on which the license holder carries a handgun is
- 13 owned or leased by a governmental entity [and is not a premises or
- 14 other place on which the license holder is prohibited from carrying
- 15 the handgun under Section 46.03 or 46.035].
- SECTION 3. Section 46.03(c)(1), Penal Code, is amended to
- 17 read as follows:
- 18 (1) "Premises" means a building or a portion of a
- 19 building. The term does not include any public or private driveway,
- 20 street, sidewalk or walkway, parking lot, parking garage, or other
- 21 parking area, or any portion of the building in which the activity
- 22 prompting the prohibition is not then ongoing [has the meaning
- 23 assigned by Section 46.035].
- SECTION 4. Section 46.035, Penal Code, as amended by

- 1 Chapters 1214 (H.B. 1889) and 1222 (H.B. 2300), Acts of the 80th
- 2 Legislature, Regular Session, 2007, is amended to read as follows:
- 3 Sec. 46.035. UNLAWFUL CARRYING OF HANDGUN BY LICENSE
- 4 HOLDER. (a) A license holder commits an offense if the license
- 5 holder carries a handgun on or about the license holder's person
- 6 under the authority of Subchapter H, Chapter 411, Government Code,
- 7 and intentionally fails to conceal the handgun.
- 8 (b) [A license holder commits an offense if the license
- 9 holder intentionally, knowingly, or recklessly carries a handgun
- 10 under the authority of Subchapter H, Chapter 411, Government Code,
- 11 regardless of whether the handgun is concealed, on or about the
- 12 license holder's person:
- 13 [(1) on the premises of a business that has a permit or
- 14 license issued under Chapter 25, 28, 32, 69, or 74, Alcoholic
- 15 Beverage Code, if the business derives 51 percent or more of its
- 16 income from the sale or service of alcoholic beverages for

1 home administration, as appropriate; 2 [(5) in an amusement park; or on the premises of a church, synagogue, or other 3 established place of religious worship. 4 5 [(c) A license holder commits an offense if the license holder intentionally, knowingly, or recklessly carries a handgun 6 under the authority of Subchapter H, Chapter 411, Government Code, 7 8 regardless of whether the handgun is concealed, at any meeting of a governmental entity. 9 $[\frac{d}{d}]$ A license holder commits an offense if, while 10 intoxicated, the license holder carries a handgun under the 11 authority of Subchapter H, Chapter 411, Government Code, regardless 12 of whether the handgun is concealed. 13 14 (c) [(e)] A license holder who is licensed as a security 15 officer under Chapter 1702, Occupations Code, and employed as a security officer commits an offense if, while in the course and 16 17 scope of the security officer's employment, the security officer violates a provision of Subchapter H, Chapter 411, Government Code. 18 (d) $[\frac{f}{f}]$ In this section, "license [+ 19 [(1) "Amusement park" means a permanent indoor or 20 outdoor facility or park where amusement rides are available for 21 use by the public that is located in a county with a population of 22 more than one million, encompasses at least 75 acres in surface 23

- SECTION 6. Section 411.179(c), Government Code, is amended

- 1 In adopting the form of the license under Subsection (a), the department shall establish a procedure for the license of a 2 3 qualified handgun instructor [or of a judge, justice, prosecuting attorney, or assistant prosecuting attorney, as described by 4 Section 46.15(a)(5)(A), (B), or (C) [46.15(a)(4) or (6)], Penal 5 Code, on the license the license holder's status as a 6 qualified handgun instructor [or as a judge, justice, district 7 attorney, criminal district attorney, or county attorney]. In 8 establishing the procedure, the department shall 9 require 10 sufficient documentary evidence to establish the license holder's status under this subsection. 11
- 12 SECTION 7. Section 411.198(b), Government Code, is amended 13 to read as follows:
- (b) It is a defense to prosecution under Section 46.035(a) [46.035], Penal Code, that the actor, at the time of the commission of the offense, was the holder of an alias license issued under this section.
- SECTION 8. Section 11.041(a), Alcoholic Beverage Code, is amended to read as follows:
- 20 (a) Each holder of a permit [who is not otherwise required 21 to display a sign under Section 411.204, Government Code,] shall 22 display in a prominent place on the permit holder's premises a sign 23 giving notice that it is unlawful for a person to carry a weapon on 24 the premises unless the weapon is a concealed handgun of the same 25 category the person is licensed to carry under Subchapter H, 26 Chapter 411, Government Code.
- 27 SECTION 9. Section 11.61(e), Alcoholic Beverage Code, is

- 2 SECTION 13. The change in law made by this Act applies only
- 3 to an offense committed on or after the effective date of this Act.
- 4 An offense committed before the effective date of this Act is
- 5 governed by the law in effect when the offense was committed, and
- 6 the former law is continued in effect for that purpose. For
- 7 purposes of this section, an offense was committed before the
- 8 effective date of this Act if any element of the offense occurred
- 9 before that date.
- 10 SECTION 14. This Act takes effect September 1, 2015.
