## AN ACT

2 relating to the authority of a person who is licensed to carry a 3 handgun to openly carry a holstered handgun; creating a criminal 4 offense; providing penalties; amending provisions subject to a 5 criminal penalty.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Section 11.041(a), Alcoholic Beverage Code, is 8 amended to read as follows:

9 (a) Each holder of a permit who is not otherwise required to 10 display a sign under Section 411.204, Government Code, shall 11 display in a prominent place on the permit holder's premises a sign 12 giving notice that it is unlawful for a person to carry a weapon on 13 the premises unless the weapon is a [concealed] handgun the person 14 is licensed to carry under Subchapter H, Chapter 411, Government 15 Code.

SECTION 2. Section 11.61(e), Alcoholic Beverage Code, is amended to read as follows:

(e) Except as provided by Subsection (f) or (i), the commission or administrator shall cancel an original or renewal permit if it is found, after notice and hearing, that the permittee knowingly allowed a person to possess a firearm in a building on the licensed premises.
