## A BILL TO BE ENTITLED

## AN ACT

2 relating to eliminating certain state-required assessment 3 instruments administered to public school students in certain 4 grades.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 39.023(a), Education Code, as effective until on or before September 1, 2015, is amended to read as follows: 7 8 (a) The agency shall adopt or develop appropriate 9 criterion-referenced assessment instruments designed to assess essential knowledge and skills in reading, [writing,] mathematics, 10 [social studies,] and science. Except as provided by Subsection 11 12 (a-2), all students, other than students assessed under Subsection (b) or (1) or exempted under Section 39.027, shall be assessed in: 13

14 (1) mathematics, annually in grades three through
15 seven without the aid of technology and in grade eight with the aid
16 of technology on any assessment instrument that includes algebra;

17 18 (2) reading, annually in grades three through eight;

18 (3) [writing, including spelling and grammar, in 19 grades four and seven;

essential knowledge and skills in reading, [writing,] mathematics,
[social studies,] and science. Except as provided by Subsection
(a-2), all students, other than students assessed under Subsection
(b) or (1) or exempted under Section 39.027, shall be assessed in:

(1) mathematics, annually in grades three through
seven without the aid of technology and in grade eight with the aid
of technology on any assessment instrument that includes algebra;
(2) reading, annually in grades three through eight;

12 Act does not receive the vote necessary for immediate effect, this

Act takes effect September 1, 2015.
