SECTION 3. Chapter 81, Family Code, is amended by adding
8 Section 81.011 to read as follows:

USE OF DIGITIZED SIGNATURE.</u> (a) A digitized 10 <u>signature on an application for a protective order under this title</u> 11 <u>or any other pleading or order in a proceeding under this title</u> 12 <u>satisfies the requirements for and imposes the duties of</u> 13 <u>signatories to pleadings, motions, and other papers identified</u> 14 <u>under Rule 13, Texas Rules of Civil Procedure.</u>

15 (b) A digitized signature under this section may be applied 16 only by, and must remain under the sole control of, the person whose 17 signature is represented.

18 SECTION 4. The changes in law made by this Act apply only to 19 a proceeding that is commenced on or after the effective date of 20 this Act. A proceeding that is commenced before that date is 21 governed by the law in effect on the date the proceeding was 22 commenced, and the former law is continued in effect for that 23 purpose.
