This Act is a revision for purposes of Section 43, Article III, Texas Constitution, and has the purposes of: 11 12 (1)codifying without substantive change or providing 13 for other appropriate disposition of various statutes that were omitted from enacted codes; 14 15 (2) conforming codifications enacted by the 83rd Legislature to other Acts of that legislature that amended the laws 16 17 codified or added new law to subject matter codified; 18 (3) making necessary corrections to enacted codifications; and 19 renumbering or otherwise redesignating titles, 20 (4) chapters, and sections of codes that duplicate title, chapter, or 21 22 section designations. SECTION 1.002. (a) The repeal of a statute by this Act does 23 24 not affect an amendment, revision, or reenactment of the statute by

1 the 84th Legislature, Regular Session, 2015. The amendment, 2 revision, or reenactment is preserved and given effect as part of 3 the code provision that revised the statute so amended, revised, or 4 reenacted.

5 (b) If any provision of this Act conflicts with a statute 6 enacted by the 84th Legislature, Regular Session, 2015, the statute 7 controls.

8 SECTION 1.003. (a) A transition or saving provision of a 9 law codified by this Act applies to the codified law to the same 10 extent as it applied to the original law.

(b) The repeal of a transition or saving provision by this Act does not affect the application of the provision to the codified law.

14 (c) In this section, "transition provision" includes any 15 temporary provision providing for a special situation in the 16 transition period between the existing law and the establishment or 17 implementation of the new law.

18 SECTION 1.004. (a) The repeal of a law, including a 19 validating law, by this Act does not remove, void, or otherwise 20 affect in any manner a validation under the repealed law. The 21 validation is preserved and continues to have the same effect that 22 it would have if the law were not repealed.

(b) Subsection (a) of this section does not diminish the

2 (7) the right to be informed, upon request, of parole procedures, to participate in the parole process, to be notified, 3 4 if requested, of parole proceedings concerning a defendant in the victim's case, to provide to the Board of Pardons and Paroles for 5 inclusion in the defendant's file information to be considered by 6 7 the board prior to the parole of any defendant convicted of any crime subject to this subchapter, and to be notified, if requested, 8 9 of the defendant's release;

10 the right to be provided with a waiting area, (8) 11 separate or secure from other witnesses, including the offender and 12 relatives of the offender, before testifying in any proceeding 13 concerning the offender; if a separate waiting area is not available, other safeguards should be taken to minimize 14 the victim's contact with the offender and the offender's relatives and 15 16 witnesses, before and during court proceedings;

(9) the right to prompt return of any property of the victim that is held by a law enforcement agency or the attorney for the state as evidence when the property is no longer required for that purpose;

(10) the right to have the attorney for the state notify the employer of the victim, if requested, of the necessity of the victim's cooperation and testimony in a proceeding that may necessitate the absence of the victim from work for good cause;

(11) the right to request victim-offender mediation coordinated by the victim services division of the Texas Department of Criminal Justice;

1 (12) the right to be informed of the uses of a victim 2 impact statement and the statement's purpose in the criminal 3 justice system, to complete the victim impact statement, and to 4 have the victim impact statement considered:

5 (A) by the attorney representing the state and 6 the judge before sentencing or before a plea bargain agreement is 7 accepted; and

8 (B) by the Board of Pardons and Paroles before an9 inmate is released on parole;

for a victim of an assault or sexual assault who 10 (13)11 is younger than 17 years of age or whose case involves family violence, as defined by Section 71.004, Family Code, the right to 12 have the court consider the impact on the victim of a continuance 13 requested by the defendant; if requested by the 14 attorney 15 representing the state or by counsel for the defendant, the court 16 shall state on the record the reason for granting or denying the continuance; and 17

20 (F) reports of restraint and seclusion required21 by Section 37.0021; and

(G) use of corporal punishment as provided by
Section 37.0011; [and]

(10) developing procedures for allowing a student in substitute care who was previously enrolled in a course required for graduation the opportunity, to the extent practicable, to complete the course, at no cost to the student, before the beginning

1 of the next school year;

2 (11)ensuring that a student in substitute care who is not likely to receive a high school diploma before the fifth school 3 4 year following the student's enrollment in grade nine, as determined by the district, has the student's course credit accrual 5 and personal graduation plan reviewed; [and] 6

(b) Fees collected under Subsection (a) shall be used only for the construction and maintenance of the roads described by or designated under Section <u>623.363</u> [623.322] and for the authority's administrative costs, which may not exceed 15 percent of the fees collected. The authority shall make payments to the Texas Department of Transportation to provide funds for the maintenance of roads and highways subject to this subchapter.
