- 9 CHAPTER 104. ACREAGE CONTRACTS AND QUANTITY CONTRACTS
- Sec. 104.001. DEFINITIONS. In this chapter:
- 11 (1) "Acreage contract" means a contract that requires
- 12 <u>a producer to deliver to a purchaser all of the production of a</u>
- 13 specified agricultural product grown on land described in the

- 16 requires a producer to deliver a specified quantity of an
- 17 agricultural product.
- 18 (2) "Producer" means a person who produces an
- 19 agricultural product and sells the product under an acreage
- 20 contract or a quantity contract.
- 21 (3) "Purchaser" means a person who purchases an
- 22 agricultural product under an acreage contract or a quantity
- 23 contract.
- 24 (4) "Quantity contract" means a contract that requires

- 1 a producer to deliver to a purchaser a specified quantity of an
- 2 agricultural product, regardless of the amount of the product grown
- 3 by the producer.
- 4 Sec. 104.002. CONTRACT TYPE DISCLOSURE. A contract between
- 5 a producer and a purchaser regarding an agricultural product must
- 6 clearly and conspicuously state on its face that it is an acreage
- 7 <u>contract or a quantity contract, as applicable.</u>
- 8 Sec. 104.003. SUIT BY PURCHASER UNDER ACREAGE CONTRACT. A
- 9 purchaser may not file suit against a producer under an acreage
- 10 contract unless the producer knowingly fails to deliver to the
- 11 purchaser all of an agricultural product grown on specified land as
- 12 provided by the acreage contract.
- SECTION 3. Chapter 104, Agriculture Code, as added by this
- 14 Act, applies only to a contract executed on or after the effective
- 15 date of this Act. A contract executed before the effective date of
- 16 this Act is governed by the law in effect when the contract was
- 17 executed, and the former law is continued in effect for that
- 18 purpose.
- 19 SECTION 4. This Act takes effect September 1, 2017.
