serve on a court under Section 32, Article V, Texas Constitution.
 This subsection expires February 1, 2039.

3 (c-2) The supreme court shall establish the term limits as
4 required by Subsection (a) not later than December 1, 2018. This
5 subsection expires December 1, 2019.

6 SECTION 2. This Act takes effect January 1, 2018, but only 7 if the constitutional amendment proposed by the 85th Legislature, 8 Regular Session, 2017, limiting to two the number of terms for which a person may be elected or appointed to hold certain state offices 9 and requiring the legislature to establish limits on the number of 10 terms judges and justices may serve on courts in this state is 11 approved by the voters. If that amendment is not approved by the 12 voters, this Act has no effect. 13
