- 14 conditions contained in Subdivision (1) of Section 23.51 [of this
- 15 $\frac{\text{code}}{\text{code}}$]. The rules, before taking effect, must be approved by $\underline{\text{the}}$

- 19 comptroller, the attorney general, the agriculture commissioner,

of appraising qualified timber land, and each appraisal office 1 2 shall use the appraisal manuals in appraising qualified timber The comptroller by rule shall develop and the appraisal 3 office shall enforce procedures to verify that land meets the conditions contained in Section 23.72 [of this code]. The rules, 5 6 before taking effect, must be approved by the comptroller with the 7 review and counsel of the Texas A&M Forest Service [majority vote of a committee comprised of the following officials or their 8 designees: the governor, the comptroller, the attorney general, the 10 agriculture commissioner, and the Commissioner of the General Land Office]. 11
