The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The Chair laid out HB 3772, sponsored by Senator Parker, as a matter of pending business. Senator King moved that HB 3772 be reported favorably to the full Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The Chair laid out HB 4219, sponsored by Senator Creighton, as a matter of pending business. Senator King moved that HB 4219 be reported favorably to the full Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 10 ayes, 1 nay, 0 present not voting, and 0 absent.

The Chair laid out CSHB 4389, sponsored by Senator Zaffirini, as a matter of pending business. Senator King moved adoption of the committee substitute; without objection, it was so ordered.

Senator King moved that HB 4389 do not pass but the committee substitute do pass and be printed. The motion carried with a record vote of 9 ayes, 2 nays, 0 present not voting, and 0 absent.

The Chair laid out CSHB 4524, sponsored by Senator Hall, as a matter of pending business. Senator King moved adoption of the committee substitute; without objection, it was so ordered. Senator King moved that HB 4524 do not pass but the committee substitute do pass and be printed. The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The Chair laid out HB 4542, sponsored by Senator Blanco, as a matter of pending business. Senator King moved that HB 4542 be reported favorably to the full Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The Chair laid out HB 4579, sponsored by Senator Hughes, as a matter of pending business. Senator King moved that HB 4579 be reported favorably to the full Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

The Chair laid out HCR 26, sponsored by Senator Creighton, as a matter of pending business. Senator King moved that HCR 26 be reported favorably to the full Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. The Chair moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

Senator King assumed the chair.

The Chair laid out HB 3615, sponsored by Senator Schwertner, as a matter of pending business. Senator Schwertner sent up the committee substitute to HB 3615. The Chair recognized the Senate Sponsor to explain the difference between the committee substitute and the bill as engrossed. Senator Schwertner moved adoption of the committee substitute; without objection, it was so ordered. Senator Nichols moved that HB 3615 do not pass but the committee substitute do pass and be printed. The motion carried with a record vote of 7 ayes, 4 nays, 0 present not voting, and 0 absent.

Senator Schwertner resumed the chair.

There being no further business, at 1:28 PM, the Chair moved that the Committee stand recessed subject to the call of the chair. Without objection, it was so ordered.
