## A JOINT RESOLUTION

- 1 proposing a constitutional amendment providing for the
- 2 establishment of the Dementia Prevention and Research Institute of

- 8 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 9 SECTION 1. Article III, Texas Constitution, is amended by
- 10 adding Section 68 to read as follows:
- 11 Sec. 68. (a) The legislature shall establish the Dementia
- 12 Prevention and Research Institute of Texas to:
- 13 (1) award grants to institutions of learning, advanced
- 14 medical research facilities, public or private persons, and
- 15 collaboratives in this state to provide money for:
- 16 (A) research into the causes of, means of
- 17 prevention of, and treatment and rehabilitation for dementia,
- 18 Alzheimer's disease, Parkinson's disease, and related disorders;
- 19 (B) research, including translational research,
- 20 to develop therapies, protocols, medical pharmaceuticals, or
- 21 procedures for the substantial mitigation of the symptoms of
- 22 dementia, Alzheimer's disease, Parkinson's disease, and related
- 23 disorders;
- (C) facilities, equipment, and other costs

- 1 related to research on dementia, Alzheimer's disease, Parkinson's
- 2 disease, and related disorders; and
- 3 (D) prevention programs and strategies to
- 4 mitigate the detrimental health impacts of dementia, Alzheimer's
- 5 disease, Parkinson's disease, and related disorders;
- 6 (2) support institutions of learning and advanced

- 25 (c) The Dementia Prevention and Research Fund is
- 26 established as a special fund in the state treasury outside the
- 27 general revenue fund to be administered by the Dementia Prevention

and Research Institute of Texas. The comptroller of public 1 2 accounts shall credit to general revenue interest due to the fund. (c-1) On January 1, 2026, the comptroller shall transfer \$3 3 billion from this state's general revenue fund to the Dementia 4 Prevention and Research Fund. The transfer made under this 5 subsection is not an appropriation of state tax revenues for the 6 purposes of Section 22, Article VIII, of this constitution. This 7 8 subsection expires January 1, 2029. 9 (d) The Dementia Prevention and Research Fund consists of: 10 (1) money transferred to the fund under this section; 11 (2) money the legislature appropriates, credits, or 12 transfers to the fund; and (3) gifts and grants, including grants from the 13 14 federal government, and other donations received for the fund. 15 (e) Notwithstanding any other provision of this constitution, the Dementia Prevention and Research Institute of 16 17 Texas, as established by general law, may use money in the Dementia Prevention and Research Fund only for the purpose of funding: 18 19 (1) grants for research on dementia, Alzheimer's disease, Parkinson's disease, and related disorders, research 20 facilities, and research opportunities in this state: 21 22 (A) for the <u>prevention</u>, <u>treatment</u>, <u>and</u> rehabilitation of dementia, Alzheimer's disease, Parkinson's 23 24 disease, and related disorders and the mitigation of the incidence of and detrimental health impacts from dementia, Alzheimer's 25

(B) to develop therapies, protocols, medical

- 9 Dementia Prevention and Research Institute of Texas carried forward

- 12 and Research Fund to the institute for a state fiscal year.
- 13 (g) Before the Dementia Prevention and Research Institute
- 14 of Texas may award a grant authorized under this section, the grant

- (h) The reasonable expenses of managing the assets of the
