Relating to excused absences from public school for the purpose of attending a released time course.

SB 1191 Creighton | et al.
Relating to the development of a standard method of computing a student's high school grade point average.

SB 2398 Campbell | et al.
Relating to certain policies and procedures related to concussions or other brain injuries sustained by public school students.

SB 2920 Campbell | et al. Posting Rule Suspended
Relating to the regulation of steroid use by students participating in
athletic competitions sponsored or sanctioned by the University
Interscholastic League.
