Relating to programs within the Office of the Governor and the Texas Economic Development and Tourism Office.

Relating to the establishment of the Quad-Agency Child Care Initiative and the Quad-Agency Child Care Initiative Commission.

HB 4996 Dyson

Relating to increasing the criminal penalty for the offense of refusal to execute the release of a fraudulent lien or claim.

HB 5122 Harris Davila

Relating to certain duties of the Texas Workforce Commission with respect to child-care resources.
